COMMON ORAL ORDER

1. By way of Civil Application (For Amendment) No. 2 of 2026, the applicants have prayed for the following reliefs;

“11. ...

A. This Hon’ble Court may be pleased to allow this Civil Application seeking amendment and permit the Applicants to amend the Special Civil Application No. 17422 of 2025 in terms of Paragraph No. 3 to 6 of this application and consequently, add Paragraph Nos. 2. 14, Grounds 3.9, 30.10 and 3.11 and Prayers AA and BB in the Special Civil

Application No. 17422 of 2025; and

B. Such other and further reliefs as may be deemed necessary in the interest of justice.”

2. Heard. Considering the fact that, by way of Civil Application No.2 of 2026, the applicants seek to amend prayers and certain factual aspects, which is not opposed by the learned AGP, on the ground that this is a fresh matter, wherein, the notice is not issued yet and hence, subject to the right of the Respondent-State to file a detailed reply and to oppose the main matter, this civil application is **allowed**. Necessary amendment to be carried out within the period of **one week**, from today. Civil Application No. 2 of 2026 stands **disposed of**, accordingly.
