ORAL ORDER**

1. Heard learned Advocate Mr. Altaf Charkha appearing on behalf of the applicant and learned Additional Public Prosecutor Mr. Aditya Jadeja appearing on behalf of the respondent-State.
2. **Rule.** Learned APP waives service of rule on behalf of the respondent-State.
3. The applicant has filed this application under Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for enlarging the applicant on Regular Bail in connection with FIR being C.R. No. 11207002250528 of 2025 registered with Godhra Town 'B' Division Police Station, District Panchmahal, for the offence punishable under Sections 5(1), 6(A), 6(B), 8(2), 8(4) and 10 of the Gujarat Animal Preservation Act, 2011 (Amendment Act, 2017), Section 325 of the Bharatiya Nyaya Sanhita,

2023 and Section 119 of the Gujarat Police Act.

4. Learned advocate for the applicant would submit that considering the role attributed to the applicant, and nature of the allegation levelled, the applicant may be enlarged on regular bail. It is further submitted that since the charge-sheet is filed, no useful purpose would be served by keeping the applicant in jail for indefinite period. It is further contended that the applicant is ready and willing to abide by all the conditions that may be imposed by this Court if released on bail.

5. As against the same, learned Additional Public Prosecutor appearing for the respondent – State has vehemently objected to the grant of regular bail. Learned APP has submitted that looking to the nature of offence and the role attributed to the present applicant as coming out from the charge-sheet, this Court may not exercise the discretion in favour of the applicant and the application may be dismissed.

6. I have heard learned advocates appearing on behalf of the respective parties and perused the papers. Following aspects are considered:-

- i. Allegation being that the accused had indulged in offence punishable under the provisions of the Gujarat Animal Preservation Act etc., more particularly the allegation being that the accused were

slaughtering the prohibited animals i.e. cow progeny.

ii. The fact of the secret information having been received against one Juber, original accused No.3. The secret information itself revealing that the said Juber had engaged other persons to do the activity.

iii. It also appears that brother of the main accused Juber had been found at the spot and whereas upon the police raid, Juber appearing to have absconded.

iv. The fact of the main accused Juber having been apprehended recently according to learned APP.

v. The fact of the applicant being in custody since 12.09.2025, the charge-sheet having been laid and the applicant having one antecedent, which is not co-relatable to the present offence, more particularly for an offence punishable under Sections 115(2) etc. of the BNS.

This Court has taken into consideration the law laid down by the Hon'ble Apex Court in the case of **Sanjay Chandra v. Central Bureau of Investigation reported in [2012] 1 SCC 40.**

7. In the facts and circumstances of the case and considering the nature of the allegations made against the applicant in the First

Information Report, without discussing the evidence in detail, prima facie, this Court is of the opinion that this is a fit case to exercise the discretion and enlarge the applicant on regular bail.

8. Hence, the present application is allowed. The applicant is ordered to be released on bail in connection with FIR being C.R. No. 11207002250528 of 2025 registered with Godhra Town 'B' Division Police Station, District Panchmahal, on executing a bond of Rs.10,000/- (Rupees Ten Thousand only) with one surety of the like amount to the satisfaction of the trial Court and subject to the conditions that he shall;

[a] not take undue advantage of liberty or misuse liberty;

[b] not act in a manner injurious to the interest of the prosecution;

[c] surrender passport, if any, to the lower court within a week;

[d] not leave the State of Gujarat without prior permission of the Sessions Court concerned;

[e] furnish the present address of residence to the I.O. and also to the Court at the time of execution of the bond and shall not change the residence without prior intimation to the I.O.;

[f] mark presence once a month for a period of six months before the concerned police station.

9. The Authorities will release the applicant only if he is not required in connection with any other offence for the time being. If breach of any of the above conditions is committed, the Sessions Court concerned will be free to take appropriate action in the matter.

10. Bail bond to be executed before the lower court having jurisdiction to try the case. It will be open for the concerned Court to delete, modify and/or relax any of the above conditions in accordance with law.

11. At the stage of trial, the trial court shall not be influenced by any observations of this Court which are of preliminary nature made at this stage, only for the purpose of considering the application of the applicant for being released on regular bail.

12. The application is allowed in the aforesaid terms. Rule is made absolute to the aforesaid extent. Direct service is permitted.
