WHEREAS the Petitioners above named through their Advocate Sri Madas Bharath Chandra, presented this petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or orders, direction or writ more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents herein in not considering the representations dated 06.12.2023, 11.12.2023 and 20.12.2023 made by the petitioners seeking enhancement of compensation for the land being acquired and consequently direct the respondents to make a reference U/s. 10 of the Petroleum and Mineral Pipelines (Land User Rights) Act, 1962;

AND WHEREAS the High Court upon perusing the petition and affidavit filed therein, and upon hearing the arguments of Sri Madas Bharath Chandra, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
