The Court made the following

ORDER

When the matter is taken up for hearing, learned counsel for the petitioner informed this court that there are arrears of interim maintenance amounting to Rs.60 lakhs. Out of which, the petitioner is ready to pay Rs.20 lakhs.

In view of the above submission, the petitioner is directed to pay Rs.20 lakhs (Rupees twenty lakhs only) within a period of four weeks from the date of receipt of copy of this order. Further, the petitioner is also directed to pay school fees etc., on the information given by the respondent.

Respondent is directed to provide passport, OCI details and school particulars to the petitioner so as to enable him to pay school fee regularly.
