Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction, more particularly one in the nature of a Writ of Mandamus, declaring the action of the respondents in disqualifying the petitioner from bidding for the Tender ID 644517 consequent to Tender Notice No.E1/DB/MCK/8201/241/2025-26/38 Dated.15.11.2025 on the ground that bids submitted by petitioner is invalid as per G.O.Ms.No.59 Irrigation and CAD(Reforms) Department dated.21-05-2018 as illegal, arbitrary, and violative of Articles 14, 16 and 21 of the Constitution of India, set aside the same and consequently direct the bid submitted by petitioner as valid, process the same and award the work in favour of the petitioner.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to process the bid submitted by the petitioner with Tender Id No.644517 pursuant to Tender Notice No.E1/DB/MCK/8201/241/2025-26/38 Dated.15.11.2025, without reference to disqualification of the petitioner at the evaluation stage, pending disposal of WP 1316 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of DR.J. Vijayalaxmi Advocate for the Petitioner, GP FOR MCPL ADMN AND URBAN DEV

for the Respondent No.1, GP FOR REVENUE for the Respondent No.2, Standing Counsel for Karimnagar Municipal Corporation for respondent No.3 and GP FOR IRRIGATION for the Respondent No.4, the Court made the following.

ORDER:

Heard learned counsel for the petitioner.

Learned Standing Counsel for Karimnagar Municipal Corporation appearing for respondent No.3 shall get instructions.

List this case on 13.02.2026.

Meanwhile, there shall be interim direction to the respondent No.3 to consider the representation, dated 05.01.2026, filed by the petitioner in terms of Point No.7(5) of G.O.Ms.NO.59, dated 21.05.2018, of Irrigation and CAD (Reforms) Department, within a period of six (06) days from the date of receipt of copy of this order. Until such exercise is done, *status quo*, obtaining as on today shall be maintained pursuant to the tender notice, dated 15.11.2025.
