1. Whether the act of respondent No. 1 in distributing the four wheeler wooden pushing carts to two woman voters of the Kukatpalle Constituency -046 on 17.10.2023 i.e., after the Model Code of Conduct is notified and was under enforcement on 10.10.2023, amounts to corrupt practices?
2. Whether the election Petitioner is entitled to declare him as elected candidate for 046- Kukatpalle Assembly Constituency Legislative Assembly

Constituency, Medchal-Malkajgiri District, Telangana State as he secured highest votes?

3. Whether the Election Petition is maintainable, in view of the submissions made by respondent No. 1 ?

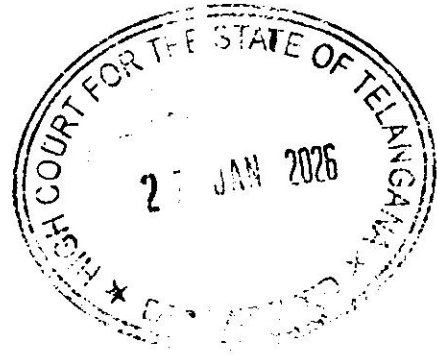
