No. 8575 of 2020, dated 05-01-2024;

WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein, and the order of this Court dt. 31.01.2025, made the following:

ORDER:

This contempt case is filed praying to punish the respondents under Sections 10 to 12 of the Contempt of Court Act, for intentionally and willfully disobeying the orders passed by this Court in W.P.No.8575 of 2020 dated 05.01.2024.

Learned standing counsel appearing for respondent No.4 has placed a letter before this Court which was addressed by respondent No.4 to respondent No.5 dated 25.04.2026 wherein it is submitted that the Secretary, Municipal Administration Department has issued sanction orders for an amount of Rs.21,47,02,000/- towards compensation to the petitioners lands acquired by the Land Acquisition Officer, Khammam in laying of 80 feet bypass road from Indira Nagar Colony to Pakabanda Village in Khammam District. It is further submitted that the District Treasury Officer, Khammam has suggested that in the mentioned Budget Release Order (B.R.O.) the amount has been adjusted to District Treasury Officer, Hyderabad (Urban) and instructed to co-ordinate with Municipal Administration Department to resolve the issue at the earliest and as per the information from the concerned section officer it has been identified that the H.O.A:2217-80-191-25-89-530-532 could not be mapped to DDO Code Khammam Municipal Corporation and the amount has been transferred to the D.D.O Code of Commissioner & Director of Municipal Administration, T.S.Hyderabad, as such respondent No.4 has addressed a letter to respondent No.5 requesting to adjust the sanctioned amount to Khammam Municipal Corporation to pay to the Land Acquisition Officer and Revenue Divisional Officer, Khammam for payment towards the petitioners. Learned standing counsel further submits that unless the respondent No.5 transfers the amount, they cannot pay the compensation amount to the land losers.

In that view of the matter, since the Commissioner and Director of Municipal Administration, T.S.Hyderabad works under respondent No.5, he shall ensure that immediate steps would be taken to transfer

the compensation amount of Rs.21,47,02,000/- to Khammam Municipal Corporation so as to pay compensation to the land losers within a period of (02) weeks from the date of receipt of copy of this order.
