Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No. 2 and 3 in not correcting the revenue illegal entries, and not cancelling the Pattadar Pass Book-cum-Title Deeds by considering our application no. 2300157853 and 2300157854, dated 25.10.2023, which have been issued illegally to the Respondents No. 4 to 10 in respect of Sy. No. 576/2 an extent of Ac. 01.171/2 Gts, each to the respondent No.5 and 6 total extent of Ac. 02.35 gts was illegally transferred in the name of respondent No.5 and 6, land in Sy.No. 580 an extent of Ac. 02.13 was mutated in the name of respondent no.4-10, the respondent No.5 land in Sy No.580/EE an extent of Ac. 0.2300 gts, land in Sy No.580/1 an extent of Ac. 0.0350 gts, respondent no.6 land in Sy No.580/a, an extent of Ac. 0.1100 gts, land in SyNo.580/5, an extent of Ac. 0.0200 gts, respondent no.7 land in Sy No.580/b an extent of Ac. 0.1100 gts, respondent no.8 land in Sy No.580/AA an extent of Ac. 0.2300 gts, respondent no.9 land in Sy

No.580/2 an extent of Ac. 0.1100 gts, the respondent no.10 who is the wife of petitioner No.1 was recorded land in Sy No.580/4 an extent of Ac. 0.0.200 gts and also petitioner No.2 wife Namely late Bokka Laxmi was also recorded in Sy No.580/4, an extent of Ac. 0.0.200 gts the respondent officials did not follow the due procedure, and in my absence the respondents played fraud to get their names entered into the revenue records in respect of the agriculture land, situated at Nandiwada village Shivar of Tadwai Mandal, Kamareddy District is highly arbitrary and illegal violation of Article 19,21 and 300-A of the constitution of India and against the principles of natural justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No. 2 and 3 to consider our application no. 2300157853 and 2300157854, dated 25.10.2023 land in Sy.No. 576/2 an extent of Ac. 02.35 and land in Sy.No. 580 an extent of Ac. 02.13 gts situated at Nandiwada village Shivar of Tadwai Mandal, Kamareddy District, pending disposal of WP 1616 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri ANUGU SANJEEVA REDDY, Advocate for the Petitioners and GP FOR REVENUE for the Respondent Nos.1 to 3, the Court made the following.

ORDER:

This writ petition is filed seeking declaration of the action of respondent Nos.2 and 3 in not correcting the revenue entries, which were made illegally, and for not cancelling the pattadar passbooks and title deeds issued in favour of respondent Nos.4 to 10.

Learned counsel for respondent Nos.4 to 10 would submit that the official respondents are not following the principles laid down by this Court in Chinnam Pandurangam v. Mandal Revenue Officer, Setilingampally Mandal & others (AIR 2008 AP 15) for amending the revenue records and seeks further time for filing counter.

List this matter on 10-06-2025.

There shall be interim direction to maintain status quo in respect of the subject property in all respects, as on today.
