Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Order, more particularly Writ of Mandamus declaring that the petitioner is entitled to for appointment to the post of Junior Assistant/Office Subordinate/Typist/Record Asst/Lascar etc or any other equivalent category of posts to the extent of 50 Percent of vacancies earmarked as per G.O.Ms.No.98 dt.15.04.1986 meant for displaced persons quota if necessary to create a

supernumerary post under Sriramsagar project by including his name in the displaced persons list from time to time as per the conditions and norms mentioned in various G.Os., 34, dt.20.02-2009, G.O.Ms.No.45 dt.04-07-2012 R/w G.O.Ms.No. 68 dt.17-05-2014 including the orders of the Hon'ble Tribunal in O.A.No.8208/2003 and batch dt.06-05-2004 and O.A.No.7917/2003 and as per judgment High Court in W.P.No.2346/2011, Apex Court judgment in S.L.P.No.14305/2011 and also orders in O.A.No.8405/2008 dt.28-12,2010 without reference to the rejection orders as the Awards are prior to issuance of G.O.Ms.no.98 dt.15-04-1986 and consequently hold the action of the respondents in denying employment under displaced persons category to the petitioner by setting aside the Lr.No.SE/GVC.IV/E5/CA.188/15/OA.No.8799/2010/M/572 dt.11-06-2015, Lr.SE/GVC.IV/E5/CA.192/15/OA.No.9105/2010/M/626 dt.23-06-2015, Lr.SE/GVC.IV/E5/CA.193/15/OA.1685/11/M/543 dt.11-06-2015, Lr.SE/GVC.IV/EEe/CA228/15/OA.8220/10/M/624 dt.23.06.2015, Lr.SE/GVC.IV/E5/CA.214/15/OA8203/10/M/625 dt.23-06-2015, and Lr.SE/GVC.IV/CA173/15/OA/591/11/M/1571 dt.11.06.2015 issued by the 1st respondent is illegal, arbitrary, discriminatory, unjust and contrary to the dicta laid down by the Honble Courts;

The petition coming on for hearing, upon perusing the petition and the grounds filed in support thereof and upon hearing the arguments of SRI M RAMGOPAL RAO Advocate for the Petitioners, GP FOR SERVICES II for the Respondents, the Court made the following.
