Metropolitan Magistrate, Cyberabad at Medchal, Medchal Malkajgiri District, pending disposal of Crl. P. No. 898 of 2024, on the file of the High Court.

Issue notice to respondent No.2.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by registered post with acknowledgment due and file proof of service thereof.

The learned counsel for the petitioner submitted that the petitioner, who is arrayed as A.3, is only a witness to the sale deed entered into between accused Nos. 1 & 2 and he is in no way connected with the offence of cheating under Section 420 IPC as alleged by the de facto complainant/respondent No.2.

On going through the copy of sale deed filed along with this criminal petition, it is noticed that the petitioner is only the witness to the said sale deed.

In view of the above, there shall be interim stay of all further proceedings in CC. No. 479 of 2023 pending on the file of the VIII Additional Metropolitan Magistrate, Cyberabad at Medchal, Medchal Malkajgiri District.
