Respondent No.3 is directed to stop the unauthorized construction, if any, made by respondents No.4 to 6 in the property bearing premises No.Ex-CIB H.No.103/LIG, G.P. No.1-103, admeasuring 376 square yards in Survey No.60/1, situated at Badepally Village, Jadcherla Mandal, Mahabubnagar District, without any sanctioned plan.
