WHEREAS the Petitioner above named through his Advocate M/s S. MIR MASOOD ALI KHAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any writ order or direction more in the nature of writ of Mandamus declaring the inaction of the respondents no.1 and 2 herein in considering the representations dt.05/12/2019, 09/12/2019 and 31/01/2020 submitted by the petitioner to initiate action against the illegal and unauthorised constructions being raised by the 3rd respondent in Plot no. 136 of Zamistanpur village, Musheerabad Mandal, Ramnagar Gundu, Hyderabad, which is on the backside of H.No.1-9-129/c, Ram nagar Gundu, Hyderabad, as illegal, arbitrary and contrary to law and consequently direct the respondents no.1 and 2 herein to forthwith consider the representations dt.05/12/2019, 09/12/2019 and 31/01/2020 submitted by the petitioner and initiate action on the same.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/s S. MIR MASOOD ALI KHAN, Advocate for the Petitioner, directed issue notice to Respondent No.3 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 19-02-2020 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

**IA NO: 1 OF 2020**

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents nos. 1 and 2 herein to restrain the respondent no.3 herein from proceeding further with the illegal and unauthorised constructions being raised in premises bearing in Plot no. 136 of Zamistanpur village, Musheerabad Mandal, Ramnagar Gundu, Hyderabad, which is on the backside of H.No.1-9-129/c, Ram nagar Gundu, Hyderabad, pending disposal of WP.No.2279 of 2020, on the file of the High Court.

**THE COURT MADE THE FOLLOWING ORDER:**

Heard the learned counsel for the petitioner as well as the learned standing counsel appearing for the first respondent Corporation.

Learned standing counsel, on instructions, submits that the construction activity is going on in Plot No.138, but not in Plot No.136, as alleged by the petitioner. On site inspection, the subordinate staff of the first respondent Corporation asked the petitioner to furnish the title documents as well as permission by issuing a notice and asked to stop the construction activity. Learned standing counsel also brought to the notice of this Court that the centering work for laying the roof is completed, but roof is not yet laid.

Therefore, learned counsel for the petitioner is directed to verify and report to the Court as to whether any construction activity is going on in Plot No.136 or in Plot No.138 and how he is affected by the said construction activity.

Post on 19.02.2020.

Meanwhile, issue notice to the third respondent.

Learned counsel for the petitioner is also permitted to take out personal notice to the third respondent through Registered Post with Acknowledgment Due and file proof of service in the Registry.
