SIVA PARVATHI presented this writ petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein, the High Court may be pleased to issue a Writ of Mandamus, or any other appropriate writ, order or direction, declaring the action of the 3rd Respondent in passing the Order vide Proceedings No.GMHNW/DP/130, dated 30.10.2014 and the Order passed by the 2nd Respondent/ appellate authority in the Appeal vide Proceedings PER/GR.XI/396, dated 15.4.2015 confirming the Orders passed by the 3rd Respondent dated 30.10.2014, as illegal, arbitrary and in violation of principles of natural justice and set aside the same by declaring that petitioner is entitled for the above said reasons for a declaration that petitioner is promoted to Scale-IV, W.E.F the same date on which the promotions were given for the successful candidates in the Interviews conducted during July-2013 from Scale-III to Scale-IV with all service benefits attendant to Scale-IV and in terms of money such as Gratuity, Pension, Provident Fund, Leave Encashment and such other benefits and that petitioner is entitled for Pension calculated on the basis of my salary deeming at Scale - IV as on the date of my retirement i.e., 31/01/2016 and all such benefits attendant to retired Pensioners of SBH/ SBI as per rules and regulations in the interest of Justice Or otherwise, petitioner would be put to great hardship and irreparable loss and irreparable loss.
