KADIRI KRISHNAIAH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the Proceedings issued by District Collector and chairman, DSC, 2024 Komarambheem Asifabad which is attested by District Educational Officer Komarambheem Asifabad vide Proc. No. 1219/SED/B6/TRT/2024, Dated. 13-12-2024 in cancellation of the appointment orders of the petitioner issued vide Proc.Rc. No.1219/B6/TRT/2024, dated 09-10-2024, as illegal, arbitrary, Discriminative, unjust, unconstitutional, violation of the fundamental Rights guaranteed by the constitutional of India and against to the Principles of the Natural Justice and consequently direct the respondents to appoint the petitioner in the post of School Assistant (Spl. Education) (Telugu) DSC-2024 by setting aside the cancellation proceedings issued by the respondents vide Rc.No.1219/SED/B6/TRT/2024 dated 13-12-2024 in the interest of justice;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of DR. KADIRI KRISHNAIAH Advocate for the Petitioner and GP FOR SCHOOL EDUCATION takes notice for respondent Nos.1 to 3, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
