WHEREAS the Petitioner above named through his Advocate SRI SYED MUSAB RAHIM HASHMI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondent No.5 not taking action against the Respondent No.6 also not apprehending and recovering the Gold ornaments of 300 Grams 22 Carrat worth of approx Rs.49,18,500/- taken by the Respondent No.6 from the Petitioner, inspite of FIR No.18/2026 dated 18/01/2026 registered against the Respondent No.6 on the file Respondent No.5 Police Station, as illegal, arbitrary and against the principles of natural justice and in violation of Articles 14 and 21 of the Constitution of India, besides violation of this Honourable Court directions and consequently direct the Respondent No.5 to take action against the Respondent No.6 by apprehending and recovering the Gold ornaments of 300 Grams 22 Carrat worth of approx Rs.49,18,500/-taken by the Respondent No.6 from the Petitioner also to file Final Report in FIR No.18/2026 dated 18/01/2026.

AND WHEREAS the High Court upon perusing the petition and affidavit/ filed herein and upon hearing the arguments of SRI SYED MUSAB RAHIM HASHMI Advocate for the Petitioner, SRI M. SRINIVAS, AGP FOR HOME for the Respondents No. 1 to 5 directed issue of notice to the Respondent no.6 herein to show cause as to why this WRIT PETITION should not be admitted.
