Chief Metropolitan Magistrate :: at Hyderabad, pending disposal of this Criminal Petition in the interest of justice.

The petition coming on for hearing, upon perusing the Criminal Petition and the grounds filed in support thereof and upon hearing the arguments of SRI VINOD KUMAR DESHPANDE, Senior Counsel representing SRI M SREYAS REDDY Advocate for the Petitioners, Additional Public Prosecutor, for the Respondent No.1

and Sri Avinash Desai, Senior Counsel representing Ms. Kopal Sharraf, counsel for Respondent No.2, the Court made the following.

**ORDER:**

**Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.**

**Ms.Kopal Sharraf, learned counsel, submits that she has filed vakalat on behalf of respondent No.2.**

**Sri Vinod Kumar Deshpande, learned Senior Counsel representing Sri M.Sreyas Reddy, learned counsel for the petitioners, submits that in respect of the very same proceedings in C.C.No.8232 of 2023, accused No.1 had approached this Court and filed Crl.P.No.16345 of 2025, and this Court dispensed with the appearance of the petitioner therein. He further submits that the present petitioner is also entitled to the same relief.**

**Sri Avinash Desai, learned Senior Counsel representing Ms.Kopal Sharraf, learned counsel for respondent No.2, submits that such discretion was exercised in respect of accused No.1 only, and the petitioners are not entitled to seek the very same relief granted in favour of accused No.1.**

**Learned Senior Counsel appearing for the petitioners submits that the trial has not yet commenced before the trial Court and that the matter is posted for appearance.**

**The Registry is directed to verify and post this matter along with Crl.P.No.16345 of 2025 on 16.02.2026.**

**The presence of the petitioners /accused Nos.5 and 7 in C.C.No.8232 of 2023 on the file of the II Additional Chief Metropolitan Magistrate, Hyderabad, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioners is required, they shall appear before the trial Court.**
