List this matter on 25.08.2025 for final hearing.

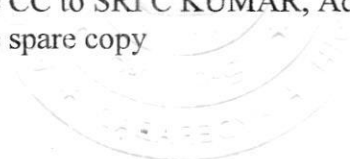
Meanwhile, interim order granted earlier shall stand extended.
