The Court made the following: ORDER

Mr. S.S.R.Murthy, learned counsel for the petitioners, submitted that WP.No.3792 of 2023 was dismissed as withdrawn by order dated 20.09.2023 on the request made by the counsel on record. He further submitted that the

petitioners did not instruct the counsel on record to withdraw the writ petition. The cause in the writ petition survives for adjudication and requested this court to set aside the order dated 20.09.2023 and the writ petition be restored to its file.

Learned counsel for the petitioners submitted that the petitioners have lodged a complaint with the Bar Council of Telangana on 11.09.2023 against the advocate, Mr. D.Amarender Reddy.

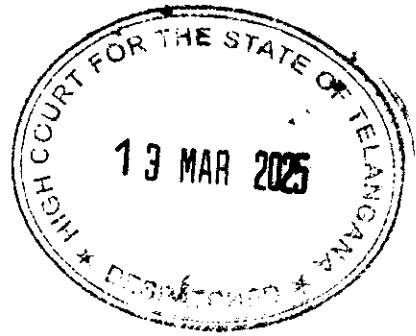
