ORDER: (Per Hon'ble Sri Justice Abhinand Kumar Shavili)

When the matter is taken up for hearing, it is noticed that the present Writ Petition is filed aggrieved by the order, dated 21.06.2024, passed in O.A.No.021/523/2023 by the Central Administrative Tribunal, Hyderabad Bench, Hyderabad. Though the impugned order, dated 21.06.2024, was passed by the Central Administrative Tribunal situated in the State of Telangana, the fact remains that Code No.021 was allotted to the subject O.A., which would mean that the subject matter pertains to the State of Andhra Pradesh. Therefore, the present Writ Petition is not maintainable before this Court. However, the petitioner is at liberty to challenge the order, dated 21.06.2024, before the High Court of Andhra Pradesh.

2. With the above observations, the Writ Petition is closed.

There shall be no order as to costs.

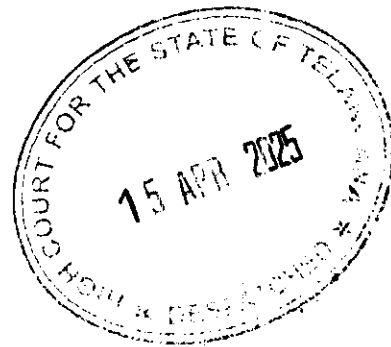
