KALVALA SANJEEV presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents No.2 to 5 in not considering the petitioner representation dated 04.02.2023 and not regularizing the service of the petitioner as Chief Executive Officer, Nandimedaram, Peddapalli District as per G.O.Ms.No.44, dated 17.12.2022 issued by the 1st respondent, is illegal, arbitrary, unconstitutional, violation of Principles of Natural Justice and violation of Articles 14, 16 and 21 of the Constitution of India and consequently direct the respondents No.2 to 5 to consider the petitioner representation dated 04.02.2023, to regularize the service of the petitioner as Chief Executive Officer, Nandimedaram, Peddapalli District as per G.O.Ms.No.44, dated 17.12.2022 issued by the 1st respondent and pass such other order or orders;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri KALVALA SANJEEV Advocate for the Petitioner and GP takes notice on behalf of respondent Nos.1 & 2, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
