Vinayaka Swamy, praying the High Court to punish the Respondents/Appellants for willful, deliberate and wanton disobedience of the directions dated 30.01.2025, passed by the this Court in I.A. No. 2 of 2025 in AS. No. 42 of 2025 in the interest of justice;

WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein, and earlier order dated 17-03-2026, made the following;

ORDER:

In compliance with the order, dated 17.03.2026, the Registry has put up proof of service.

Notice is served on respondent Nos.1 and 5. Notice on respondent No.2 is returned unserved with an endorsement that he is not working at the said place. Notice sent to respondent Nos.3 and 4 is not yet returned. Therefore, issue fresh notice to respondent Nos.3 and 4.

This Contempt Case is filed alleging willful and deliberate violation of the order, dated 30.01.2025, in I.A.No.2 of 2025 in A.S.No.42 of 2025. By the aforesaid order, this Court has granted stay of operation of the judgment impugned in the appeal on condition of the appellants depositing 50% of the decretal amount and also costs within a period of twelve weeks from the said date. According to the petitioners, the respondents did not deposit the said amount in compliance of the said order.

Despite service of notice, there is no representation on behalf of respondent Nos.1 and 5.
