The Court made the following: ORDER

This Review Application is filed seeking review of the order dated 03.03.2026 passed by this Court in C.R.P. No. 606 of 2024.

Learned counsel for the review petitioner submitted that, as per the earlier order, this Court permitted the respondent to visit his child on every Saturday from 3:00 p.m. to 5:00 p.m. at the District Legal Services Authority, L.B. Nagar.

The review petitioner now seeks modification of both the visitation time and venue on the ground that the existing place of visitation is far from the child's residence. It is further submitted that the present schedule causes inconvenience and disrupts the child's education and daily routine. Accordingly, the petitioner requests that the visitation be shifted to a nearer location, namely GSM Mall, Miyapur, Hyderabad, and that the timing be modified.

Learned counsel for the respondent is present.

In view of the submissions made and the relief sought, the Review Petition is allowed. The earlier order stands modified to the extent that the respondent is permitted to visit the child on every Saturday from 5:00 p.m. to 7:00 p.m. at GSM Mall, Miyapur, Hyderabad.

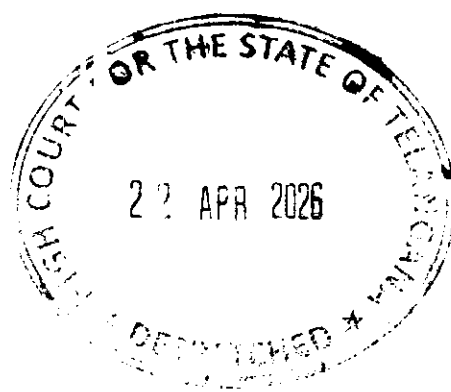
