WHEREAS the Petitioners above named through their Advocate Sri V NARESH KUMAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or direction more particularly one in the nature of writ of Mandamus to declare the action of the 2nd and 4th respondents is Illegal and Arbitrary Null and Void for Violating the Principles of Natural Justice and for not taking action against the representation dated.22-08-2025 and 25-08-2025 respectively and consequential proceedings issued by the Bhoodhan Yagna Board Lr.No TBYB/A/539/2025 dated.20-11-2025, and further not taking action against the subsequent representation dated.07-01-2026 which was submitted to the 2nd Respondent, subsequently direct the 2nd respondent to register criminal cases against the persons, who are claiming the lands by showing the proceedings of Telangana Bhoodan Yagna Board for the land in Survey no,s 318, 319, 320, 321, 322, 323 and 324 lands situated at Relakunta Village, Nallabelli Mandal, Warangal district, further recovery of the position from the Land encroachers and to declare the said lands as Government lands by establishing a board.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri V NARESH KUMAR Advocate for the Petitioners, directed issue of notice to the Respondent Nos.5 to 13 to show cause as to why this WRIT PETITION should not be admitted.
