Post on 18-02-2021.

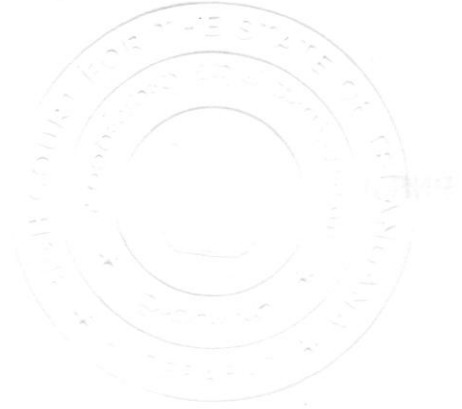
