The petition coming on for hearing, upon perusing the petition and the grounds filed in support thereof and the order of the High Court dated 18.02.2026 & 28.04.2026 made herein and upon hearing the arguments of Public Prosecutor for the Respondent No.1, Sri Murli Narayan Bung Advocate for the Petitioner (not being present), the Court made the following.

ORDER

No representation for the petitioner.

This Court, *vide* order dated 18.02.2026, granted interim stay, directing the petitioner to pay an amount of Rs.7,500/- (Rupees Seven Thousand and Five Hundred Only) per month to respondent No.2 on or before the 10th of every succeeding month, together with the arrears in the same ratio, within a period of four (4) weeks from that date i.e., 18.02.2026.

The order further records that, in the event of non-payment of the said amount, the interim order granted earlier by this Court shall stand vacated. However, there is no material on record showing that the amounts, as directed by this Court, has been paid.

Post the matter on 18.06.2026.
