There shall be interim suspension of the order dated 03.01.2025 in M.P.No.327 of 2024 in M.C.No.252 of 2024 passed by the Judge, I Additional Family Court-cum-XIV Additional Metropolitan Sessions Judge, Hyderabad, subject to the petitioner paying 50% of the

maintenance amount as directed by the trial Court i.e., Rs.10,000/- per month to respondent No.2 and Rs.5,000/- each to the respondent Nos.3 and 4, on or before 5th of every succeeding month, from the date of this order. If there are any arrears, the same shall also be paid to the extent as indicated above within four (04) months to respondent Nos.2 to 4 herein from the date of this order. In default of payment of maintenance as directed by this Court, the stay stands vacated.
