Till then, the interim order granted by this Court earlier, shall stand extended.

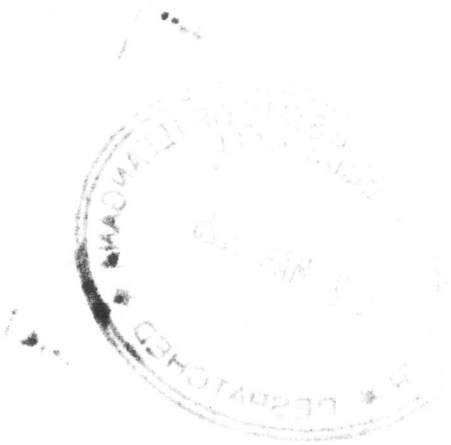
