mentally and physically and created panic situation is illegal, arbitrary, unconstitutional and violation of Articles 14, 15, 21 and 300-A of Constitution of India and also violation of Principles of Natural Justice and consequently direct the Respondent No.5 to conduct the detailed enquiry in Crime No.178 of 2025 for the offences under Section 85, 351(2) B.N.S., card 16/11/2025 on the file of Paloncha Rural Police Station and take the necessary action against the Respondent Nos.6 to 10 who are harassing, threatening the Petitioner physically, mentally and attacked on her by abusing in filthy language.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI RAPOLU BHASKAR Advocate for the Petitioner and SRI M. SRINIVAS, AGP FOR HOME for the Respondents No. 1 to 5 directed issue of notice to the Respondents No. 6 to 10 herein to show cause as to why this WRIT PETITION should not be admitted.
