WHEREAS the Petitioner above named through his Advocate Ms. PEMMARAJU SRIVALLI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ Order or Direction more particularly one in the nature of WRIT OF MANDAMUS, declaring the action of the Respondent No. 3 in not implementing the Honorable High Court orders dated 16-7-2024 in WP No. 32320 of 2023 filed by the Petitioner in regard with the disposal of the Representation of the Petitioner raising certain objections over the approval of the Respondent No. 3 of the venture named Diamond City by Respondent Nos. 5 & 6 construction company is illegal, arbitrary and violative of principles of natural justice and also against Articles 14 and 21 of the Constitution of India and
