WHEREAS the Petitioners above named through their Advocate SRI J U M V PRASAD presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High

Court may be pleased to issue a writ, order or direction more in the nature of Writ of Mandamus, declaring the action of the respondents 1 to 3 in not taking any action in pursuance to the representation dated 04.05.2018 seeking to extend the monetary benefits notionally from the date of their entry into service as Part Time Lecturers for fixation of Pensionary benefits to them in the light of the Judgment of the Honble Division Bench of this Honble Court as made in WP No. 33936/2011 and batch, dated 02.05.2018, as being illegal arbitrary and is in violation of Articles 14, 16 and 21 of the Constitution of India and consequently direct the respondents to fix up the pensionary and retirement benefits by taking into consideration of the service of the petitioners as Part time lecturers.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI. J U M V PRASAD Advocate for the Petitioner, directed issue of notice to the Respondent Nos.3 and 4 herein to show cause as to why this WRIT PETITION should not be admitted.

In view thereof,

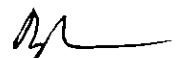
Issue notice to respondents No.3 and 4.
