Learned counsel appearing for the petitioner submitted that, despite the complaint dated 14.02.2026 having been filed by the petitioner against the unofficial respondents no action has been taken by the official respondents to date. Hence, seeks indulgence of this Court.

It is noticed that the petitioner has submitted a complaint through Speed Post on 14.02.2026. Considering that only 10 days have elapsed since the submission of the complaint, the matter requires further time for appropriate action.
