WHEREAS the Petitioner above named through his Advocate Sri Alluri Divakar Reddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents No. 2 to 4 in not providing police protection to the petitioner's agricultural land admeasuring 0.28 Guntas in Sy.No. 104/A/1 situated at Kukkadam Village, Madgulapally Mandal, Nalgonda District in pursuant to Police protection orders dated 29.01.2024 in E.A. No. 02 of 2024 in E.P. No. 04 of 2024 in O.S. No. 195 of 2023 on the file of the Hon'ble I Additional Junior Civil Judge at Miryalaguda despite receipt of petitioner's written representation dated 14.07.2025 as being illegal, arbitrary and violation of Articles 21 and 300A of Constitution of India, consequently direct the respondents No. 2 to 4 to provide police protection to the petitioner's agricultural land

admeasuring 0.28 Guntas in Sy.No. 104/A/1 situated at Kukkadam Village, Madgulapally Mandal, Nalgonda District in pursuant to Police protection orders dated 29.01.2024 in E.A. No. 02 of 2024 in E.P. No. 04 of 2024 in O.S. No. 195 of 2023 on the file of the Hon'ble I Additional Junior Civil Judge at Miryalaguda.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Alluri Divakar Reddy Advocate for the Petitioner and Assistant Government Pleader for Home for respondent Nos.1 to 4, directed issue of notice to the Respondent Nos.5 to 10 herein to show cause as to why this WRIT PETITION should not be admitted.
