WHEREAS the Petitioner above named through his Advocate SRI G PRASANTH RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to writ or order more particularly one in the nature of writ of mandamus, declaring the inaction of the 1st to 5th Respondent in not considering the representation dated 21-03-2020 in taking action against the 6th respondent for encroaching the nala and making structures over it, making drainage line passing into my House on Plot No. 61, admeasuring 167 Sq.Yards, equivalent to 139.62 Sq.Mtrs, having plinth area of 2370 Sft., Ground Plus 2 floors, situated at Sy.No. 58/1/200 SITUATED AT Ward No.8, Block No.3, Sri. Balaji Nagar, of Karmanghat Village, Saroornagar Revenue Mandal, GHMC, R.R.District, Hyderabad on the eastern side as arbitrary, illegal, and violative of Article 14 and 21 of Constitution of India and consequently direct the 1st to 5th Respondents to remove the structure made over the existing nala by the 6th respondent, and drainage line be laid in the existing nala,;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri G PRASANTH RAO Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Notice before admission.

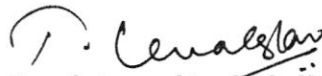
Learned counsel for the petitioner is also permitted to take out notice to the 6th respondent by Registered Post and file proof of service.
