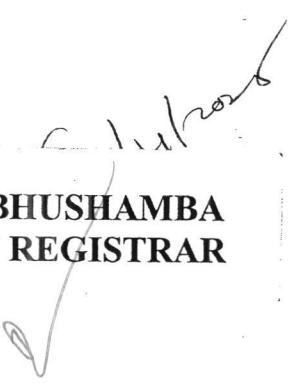
The party-in-person presses I.A.No.2 of 2025 (Direction petition).
