WHEREAS the petitioner has presented the Contempt Case under Sections 10 to 12 of the Contempt of Courts Act, 1971, through her Counsel M/s Chilla Advocates and Legal Consultants, praying the High Court to call the Contemnors/Respondents and consequently punish the respondents for their willful and deliberate disobedience of the orders passed by this Court in IA No. 03 of 2025 in W.P. No. 6654/2025 dated 07.08.2025 and modified order in IA No. 04 of 2025 in W.P. No. 6654/2025 dated 03.11.2025;

WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein, and upon hearing the arguments of M/s Chilla Advocates and Legal Consultants, Advocate for the petitioner, made the following;

ORDER:

This Contempt case is filed complaining non-implementation of the order in IA.No.03 of 2025, dated 07.08.2025 and modified order in IA.No.04 of 2025 in W.P.No.6654 of 2025 dated 03.11.2025.

Sri P.S. Rajashekar, learned Standing Counsel appearing for TGPSC, vehemently opposed the Contempt Case contending that the TGPSC is not a necessary party, as the impugned order is directed only against respondent No.2, and therefore prayed that the TGPSC be deleted from the array of party-respondents in the present Contempt Case.

On perusal of the modified interim order dated 03.11.2025, it is evident that the impugned order is directed only against respondent No.2. In view of the same and the aforesaid submission, the Registry is directed to delete the name of respondent No.1 from the array of respondents in the present C.C.

The Registry is further directed to issue notice to the respondent (Vice Chairman & Managing Director, Sports Authority of Telangana, Hyderabad) to show cause as to why she should not be punished under the Contempt of Courts Act, 1971, for non-compliance of the aforesaid order, by filing a counter-affidavit on or before 10.04.2026, failing which, she shall appear before this Court on that date at 10:30 A.M.

It is made clear that if the counter-affidavit is not filed on the date specified, the same shall not be accepted without payment of costs of Rs.10,000/- to the Registrar (Judicial) by the respondent.
