WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein, and the earlier orders dated 07-03-2025 & 18-12-2025, made the following;

ORDER:

Learned Assistant Government Pleader for Land Acquisition submitted that respondent Nos.1 and 2 herein are transferred and that Mr. Lokesh Kumar is appointed as CCLA, Hyderabad & Ms. Garima Agarwal is appointed as District Collector (FAC), Rajanna-Sircilla District.

Since the order dated 14.08.2024 in W.P.No.12937 of 2024 is not complied by the respondent Nos.1 and 2, the Registry is directed to issue Form-I to respondent Nos.1 and 2 and as the said officials were transferred, this Court deems it appropriate to suo moto implead the above officials as respondent Nos.5 and 6 in the present Contempt Case.

Hence, the Registry is directed to carry out necessary amendments in the cause title of the Contempt Case and issue Form-I to the respondent Nos.5 and 6, as the order dated 14.08.2024 in W.P.No.12937 of 2024 is not complied till date.

As per the directions of this Court on 18.12.2025, the respondent No.4 appeared before this Court, as such, the presence of respondent No.4 is hereby dispensed with.

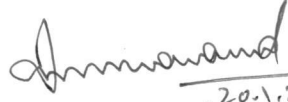
