GADDAM JALPATH REDDY SRI VENKAT REDDY praying the High Court to punish the respondent herein for willful and intentional disobedience in noncompliance of the orders in making payment of terminal benefits payable to the petitioner including Death cum Retirement, Gratuity, Commutation of Pension, General Provident Fund amount and Encashment of Earned Leave and other benefits passed in pursuance of proceedings in Lr.No.AG(A and E)/P17/IV/R-359/SP401/2025-06/ 1961 dated 29.07.2025 of the Principal Accountant General (A and E), Hyderabad viz., an amount of Rs.16,00,000/- was sanctioned towards retirement gratuity viz., Rs.13,21,895/- sanctioned vide Token No.2601124676 dated

23.08.2025 and Rs 2,78,105/- sanctioned vide Token No.2601124683 dated 23.08.2025 respectively, further an amount of Rs.25,95,523/- was sanctioned towards Commutation Value of Pension viz., Rs.21,44,380/- sanctioned vide Token No.2601124693 dated 23.08.2025 and Rs.4,51,143/- sanctioned vide Token No.2601124704 dated 23.08.2025 respectively, the Service Pension of the Petitioner was fixed as Rs.66,815/-, Encashment of Leave amount of Rs.18,62,669/- which was sanctioned vide Token No.2600108278 dated 15.04.2025, GPF amount of Rs.7,00,283/- was sanctioned vide Token No.2600244265 dated 06.05.2025, GIS amount of Rs.57,29/- was sanctioned vide Token No.2602308597 dated 04.12.2025, PRC Arrears amount of Rs.3,95,227/- was sanctioned in different token numbers on 15.04.2025 and D.A. (As per G.O.78 85 G.O.120) Arrears amount of Rs.1,00,089/- was sanctioned in different token numbers from April 2025 to December 2025 and Full Additional Charge allowances amount of Rs.59,675/- was sanctioned vide Token No.2600678278 dated 03.07.2025 in terms of the orders passed in W.P.No.1322 of 2026 dated 09.01.2026,

AND WHEREAS the said case coming on for orders as to admission on this day and whereas the High Court, upon perusing the affidavit filed therein, and upon hearing the arguments of MR. GADDAM JALPATH REDDY SRI VENKAT REDDY Advocate for the petitioner, directed issuance of notice to the respondents, herein, to show cause as to why in the circumstances stated in the affidavit filed in support thereof, the said case should not be admitted;
