Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in continuing the land in Sy. No. 132/1/4, admeasuring Ac.1-26.75 guntas and in Sy. No. 132/1/5. admeasuring Ac.1-26.50 guntas and Sy. No. 132/1/6, admeasuring Ac.1-26.50 guntas situated at Bechinelli village, Zaheerabad Randal, Sangareddy District in the prohibitory list though the said land was assigned in the name of Late Manik Rao under the category of Freedom Fighter and further, though the period of (10) years for prohibition of alienation of the said land was expired long back and further the respondents are not considering the online application of Petitioner No. 1 dated 29/01/2026 vide transaction Application No. 2600001810 and online application of Petitioner No.2 dated 22/01/2026 vide transaction Application No. 2600001624 and online application of Petitioner No.3 Dated 27/01/2026 vide transaction Application No. 2600001401 submitted by the petitioners for seeking deletion of the said lands from the prohibitory list so as to enable the petitioners to develop the said properties

and also to alienate some part of the same to third parties, as illegal, unlawful, contrary to law and consequently direct the respondents to consider the above pending online applications and delete the above land from the prohibitory list

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI ANDE SHRAVAN KUMAR Advocate for the Petitioners and GP FOR REVENUE for the Respondents, the Court made the following.

ORDER

Respondent No.2 is directed to consider the online application of the petitioners bearing Nos.2600001810 dated 29.01.2026; 2600001627 dated 27.01.2026 and 2600001401 dated 22.01.2026 for removing the land admeasuring Ac.1-26.75 guntas in Survey No.132/1/4, Ac.1-26.50 guntas in Survey No.132/1/5 and Ac.1-26.50 guntas in Survey No.132/1/6, situated at Bechinelli Village, Zaheerabad Mandal, Sangareddy District, from the prohibitory list of properties, by giving opportunity of hearing to the petitioners and all other concerned/interested persons, and pass appropriate orders in accordance with law, within a period of two (2) months from the date of receipt of a copy of this order.
