ORDER:

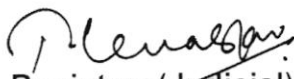
Heard learned counsel for the petitioner and learned Standing Counsel for the respondent Corporation.

There being no dispute, at this point of time, that construction permission was granted in June 2019, and that the petitioner has been making construction, as long as the construction is carried on in accordance with the sanctioned plan, the respondent Corporation shall not interfere with the same.

Further, the learned counsel for the petitioner submits that his client undertakes not to alienate the property and create 3rd party interests, so as to avoid further complications. The undertaking is made part of the record.
