Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct respondent Nos.2 and 3 not to interfere/demolish the constructions made by the petitioner over plot bearing Nos.112 (southern part) and 114 (northern part), admeasuring 133.34 sq. yards forming Sy.Nos.108 and 109, situated at Block No.2, Kothapet, Uppal Mandal, Medchal-Malkajgiri District, Pending disposal of WP No. 8023 of 2020, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Heard learned counsel for the petitioner and learned Standing Counsel for the respondent Corporation.

There being no dispute, at this point of time, that construction permission was granted in May 2019, and that the petitioner has been making construction, as long as the construction is carried on in accordance with the sanctioned plan, the respondent Corporation shall not interfere with the same.

Further, the learned counsel for the petitioner submits that his client undertakes not to alienate the property and create 3rd party interests, so

as to avoid further complications. The undertaking is made part of the record.
