Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly a Writ in the nature of Mandamus, may be pleased to issue a Writ, Order or Direction, more particularly a Writ in the nature of Mandamus, declaring the action of the respondents more particularly the respondent Nos. 4 and 5 in trying to dispossess the petitioner from the house bearing No.10-80/32/7, situated at Elagandal Village and Gram Panchayat, Kothapally Mandal, Karimnagar District without issuing any notice or without offering any explanation from the petitioner even though the petitioner has been in peaceful possession and enjoyment of the said house property since 1996 by virtue of House Site Patta, as illegal, arbitrary, high handed, discriminatory, without authority of law and void, being in derogation of Articles 14, 19, 21 and 300-A of the Constitution of India, besides in violation of principles of natural justice and consequently direct the respondents not to dispossess the petitioner from the house bearing No.10-80/32/7, situated at Elagandal Village and Gram Panchayat, Kothapally Mandal, Karimnagar District other than in due process of law, in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased direct the respondent Nos. 4 & 5 not to dispossess the petitioner from the house bearing No.10-80/32/7, situated at Elagandal Village & Gram Panchayat, Kothapally Mandal, Karimnagar District other than in due process of law, during the pendency of the writ petition, in the interest of justice, pending disposal of WP 7314 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI C KUMAR Advocate for the Petitioner, Mr. L. Ravinder, Assistant GP FOR REVENUE for the Respondent Nos. 1 to 4 and Sri Katta Pradeep Reddy, standing Counsel for the respondent No.5, the Court made the following.

ORDER

Mr. L.Ravinder, learned Assistant Government Pleader for Revenue, appearing for respondents No.1 to 4; and Mr. Katta Pradeep Reddy, learned Standing Counsel for respondent No.5; seek time to get instructions.

The petitioner claims to be the owner and possessor of the property bearing H.No.10-80/32/7, Karimnagar District on the strength of the house site patta granted in his favour bearing No.B2/4490/1995 dated 12.01.1996 issued to his father by name Mr. Madishetti Anjaneyulu and there is a house constructed in the property.

In the circumstances, *status quo* obtaining as on today shall be maintained in respect of the subject property till the next date of hearing.
