WHEREAS the Petitioners above named through their Advocate SRI THIMMARAJU RAMCHANDRA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly, one in the nature of Writ of Mandamus, declaring the action of the Respondents No. 2 to 4 in interfering with the petitioners possession over the land in Sy.Nos. 240, 260, 261 and 262 of Proddutur Village, Shankarpally Mandal, Ranga Reddy District on 24-02-2024 at the instance of Respondents No. 5 to 15, and cautioning the petitioners to evict their land, as illegal, arbitrary, unconstitutional and against the principles of natural justice, and consequently direct the Respondents No. 2 to 4 not to interfere with the peaceful possession and enjoyment of the petitioners over the land in Sy.No. 240, 260, 261 and 262 of Proddutur Village, Shankarpally Mandal, Ranga Reddy District, in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No. 2 to 4 not to interfere with the peaceful possession and enjoyment of the petitioners over the land in Sy.Nos. 240, 260, 261 and 262 of Proddutur Village, Shankarpally Mandal, Ranga Reddy District, pending disposal of WP 7285 of 2026, on the file of the High Court.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri THIMMARAJU RAMCHANDRA RAO Advocate for the Petitioners, Mr. M.Srinivas, ASST GP FOR HOME, for the respondent Nos. 1 to 4, directed issue of notice to the Respondent Nos. 5 to 15, herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 21.04.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

IA NO: 1 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No. 2 to 4 not to interfere with the peaceful possession and enjoyment of the petitioners over the land in Sy.Nos. 240, 260, 261 and 262 of Proddutur Village, Shankarpally Mandal, Ranga Reddy District, pending disposal of WP No. 7285 of 2026, on the file of the High Court.

The Court made the following: ORDER

Notice before admission.

Learned Assistant Government Pleader for Home, takes notice for respondent Nos.1 to 4, waives further notice and seeks time to get instructions.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.5 to 15 by Speed Post with Acknowledgment Due and file proof of service before the Registry by the next date of listing.

Learned counsel for the petitioners submits that the father of the petitioners was issued Occupancy Rights Certificate for the land to an extent of Acs.2.39 guntas in Sy.No.261 and Acs.6.37 guntas in Sy.No.262 situated at Proddutur Village, Shankarpally Mandal, Ranga Reddy District and

proceedings in Lr.No.4/3320/84 dated 03.01.1986 were passed by the Revenue Divisional Officer, Chevella, confirming the Occupancy Rights in favour of the petitioners father. The pahanies also reflects the father's name of the petitioners in the possession column of the pahanie for the year 1986-87, 1990-91 and the revenue authorities have also issued e-pattadar pass books and title deeds in favour of petitioner No.1. Learned counsel further submits that without having any valid documents, with the help of police personnel, the unofficial respondents are interfering with the possession of the petitioners, therefore petitioner No.2 filed a complaint against the unofficial respondents, and the respondent police have registered a case in Crime No.95 of 2026 dated 23.02.2026, therefore prays this Court to direct respondent Nos.2 to 4 not to interfere with the petitioners possession over the subject property.

Mr. M.Srinivas, learned Assistant Government Pleader for Home submits that alleging interference of one Mr.Mandumula Lakshmaiah, his wife, daughter, and Dappu Bikshappa, a complaint was filed by petitioner No.2 and based on the said complaint, a case in Crime No.95 of 2026 dated 23.02.2026 was registered for the offences under Sections 329(3), 115(2), 351(2) r/w 3(5) BNS and the said crime is under investigation.

This matter requires detailed examination and the facts can be ascertained only upon filing written instructions/counter by the official respondents.

In the meantime, respondent Nos.2 to 4 are directed not to interfere with the *inter se* disputes between the petitioners and the unofficial respondents in respect of the subject property, except under due process of law.
