WHEREAS the Petitioners above named through their Advocate Sri Syed Reyaz presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the Respondent No.6 in not disposing off the Complaint dt.7.3.2026 submitted by the petitioner Society against Respondents No.7 to 10 and others for the acts of forgery, fabrication of documents claiming the dissolved Society and interfering with the affairs of petitioner Church House of Prayer (HOPE) situated at D.No.42-521, Green Hills Colony,

Road No.1, Opp.New Kapra Municipal Office, Moulali, M.M.District as illegal, without any legal right, contrary to law, arbitrary and in violation of Articles 14, 19 and 21 of the Constitution of India apart from being violation of Principles of Natural Justice and consequently direct the Respondent No.6 not to permit the Respondents No.7 to 10 and their men from conducting any meetings illegally in the church of House of Prayer situated at D.No.42-521, Green Hills Colony, Road No.1, Opp.New Kapra Municipal Office, Moulali, M.M.District without any right, which causes law and order problem in the House of Prayer Church.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Syed Reyaz Advocate for the Petitioners and Sri M. Srinivas, Assistant G.P for Home for the respondent No. 1 to 6, directed issue of notice to the Respondent No. 7 to 11 herein to show cause as to why this WRIT PETITION should not be admitted.

ORDER:

Notice before admission.

Mr. M. Srinivas, learned Assistant Government Pleader for Home, appearing for the respondent Nos.1 to 6, would seek short accommodation of time to obtain instructions.

Issue notice to the respondent Nos.7 to 11.

Learned counsel for the petitioner is permitted to take out personal notice to the respondent Nos.7 to 11 by Speed Post with acknowledgment due (SPAD) and file proof of service.

Since it has been submitted by the learned counsel for the petitioner that despite the complaint has been made by the petitioner-Society against the respondent Nos.7 to 10, no action has been taken, learned Assistant Government Pleader for Home shall get instructions on the aspect of status of the complaint, made by the petitioner, by the next date of hearing.

List this matter on 21-04-2026.
