WHEREAS the Petitioners above named through their Advocate SRI NANDIGAM KRISHNA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus i) to declare the action of the respondent authorities in trying to interfere with the peaceful possession and enjoyment of the petitioners land in Sy.No. 55 of Kadipikonda village, Kazipet Mandal, Warangal Urban District to an extent of 31930 Sq. Yards for construction of double bed room houses without any authority of law and without initiating any land acquisition proceedings and without assigning land to the petitioners herein equivalent to value of their land as illegal arbitrary, unjust apart from violative of principles of natural justice and ii) to consequently direct the respondents not to interfere with the peaceful possession and enjoyment of the land in Sy.No. 55 of Kadipikonda village, Kazipet Mandal, Warangal Urban District to an extent of 31930 Sq. Yards;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri NANDIGAM KRISHNA RAO Advocate for the Petitioners, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
