WHEREAS the Petitioner above named through his Advocate SRI T. Sudhakar Reddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not paying the bills an amount of Rs.1,42,79,000/- (Rupees one crore forty two lakhs and seventy nine thousand only) even after completing works as per the Tender Notification vide L.S. Agreement No.21/2023-24 Dt. 28/4/2023 for Providing Railing on Existing Irrigation Tank Bund of Laxmi Cheruvu at Yadadri Temple in Yadadri-Bhongir District vide Tender L.S. Agreement No. 21/2023-24 dt. 28/4/2023, Circle, Sangareddy, DivisionYadadri-Bhongir District, in respect of contract awarded to the

petitioner agency even after completing works to the satisfactorily, as bad, arbitrary, illegal, unconstitutional and violation of principles of natural justice, consequently direct the respondents to pay / release the bill amounts of Rs.1,42,79,000/- (Rupees one crore forty two lakhs and seventy nine thousand only) with interest @ 24 percentage p.a. from the date of completion of the work by the petitioner agency in terms of L.S. Agreement No. 21/2023-24 Dt. 28/4/2023 for Providing Railing on Existing Irrigation Tank Bund of Laxmi Cheruvu at Yadadri Temple in Yadadri-Bhongir District;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri T. Sudhakar Reddy, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
