WHEREAS the Petitioner above named through his Advocate SRI T. Sudhakar Reddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not paying the bills an amount of Rs.1,21,07,734/- (Rupees one crore twenty one lakhs seven thousand seven hundred and thirty four only) even after completing works as per the Tender Notification vide Agreement No. 1/2020-21 dt. 2.10.2020, Yadadri, Yadadri-Bhongir District, for Providing Stainless Steel Railing and Seating Benches in Q Complex and Corridors at Up-Hills, SLNSD, Yadadri, Yadadri-Bhongir in terms of Agreement No. 1/2020-21 dt. 2.10.2020, Yadadri, Yadadri-Bhongir District, in

respect of contracts awarded to the petitioner agency even after completing works to the satisfactorily, as bad, arbitrary, illegal, unconstitutional and violation of principles of natural justice, consequently direct the respondents to pay / release the bill amounts of Rs.1,21,07,734/-(Rupees one crore twenty one lakhs seven thousand seven hundred and thirty four only) with interest alias 24 percentage p.a. from the date of completion of the work by petitioner agency in terms of Agreement No. 1/2020-21 dt. 2.10.2020, Yadadri, Yadadri-Bhongir District for Providing Stainless Steel Railing and Seating Benches in Q Complex and Corridors at Up-Hills, SLNSD, Yadadri, Yadadri-Bhongir;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri T. Sudhakar Reddy, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
