WHEREAS the Petitioner above named through his Advocate Sri E Venkata Siddhartha presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Order, Writ or Direction more particularly one in the nature of Writ of Mandamus, declaring the action of the 3rd respondent in granting the 38-E Certificate in favour of the unofficial respondent nos. 5 to 31 vide File Nos. L/794/2020, L/795/2020, L/796/2020, L/797/2020, L/884/2020 dated 08.05.2020 and B/1873/2021 dated 18.12.2021, to an extent of Ac.94.00 gts., in Sy.Nos. 274, 275, 276, 277, 278, 279, 280, 281, 282, 283 and 282, situated at Kongarakalan Village, Ibrahimpatnam Mandal, Ranga Reddy District, is

highly illegal, arbitrary and against the principles of natural justice and also violative of Articles 14, 19, 21 and 300-A of Constitution of India and consequently set aside the ownership Certificates issued under section 38-E of HTAL Act in favour of the unofficial respondents by the 3rd respondent;
