JALPATH REDDY SVR praying the High Court to call the respondents and punish them for their deliberate, willful and intentional disobedience in noncompliance of the orders in making payment of terminal benefits payable to the petitioner including Death cum Retirement, Gratuity, Commutation of Pension, General Provident Fund amount and Encashment of Earned Leave and other benefits passed in pursuance of proceedings in Lr.No.PAG(A and E)/P17/II/L-228/SP1002/2025-02/99 dated 03.04.2025 of the Principal Accountant General (A86E), Hyderabad viz., an amount of Rs.16,00,000/- sanctioned towards retirement gratuity viz., Rs.9,49,516/- sanctioned vide Token No.2600380864 dated 21.05.2025 and Rs.6,50,484/- sanctioned vide Token No.2600380865 dated 21.05.2025 respectively, further an amount of Rs.18,43,942/- sanctioned towards Commutation Value of Pension viz., Rs.10,94,283/- sanctioned vide Token No.2600380866 dated 21.05.2025 and Rs.7,49,659/- sanctioned vide Token No.2600380867 dated 21.05.2025 respectively, the Service Pension of the Petitioner was fixed as Rs.47,469/-, Final Encashment of Leave amount of Rs.14,66,410/-sanctioned vide Token No.2600540895 dated 12.06.2025, PRC Arrears Bill amount of Rs.6,89,458/- sanctioned vide Token No.2363640080 dated 31.03.2023, Two Incremental Arrears bills for Rs.4,10,178/- sanctioned vide Token No.2363640968 dated 31.03.2023 86 Rs.2,86,598/- sanctioned vide Token No.2522669452 dated 12.09.2024 and Leave Salary Bill for Rs.2,54,000/- sanctioned vide Token No.2522915668 dated 14.10.2024 in terms of the orders passed in W.P.No.1327 of 2026 dated 09.01.2026;
