JALPATH REDDY SVR praying the High Court to call the respondents and punish them for their deliberate, willful and intentional disobedience in noncompliance of the orders in making payment of terminal benefits payable to the petitioner including Death cum Retirement, Gratuity, Commutation of Pension, General Provident Fund amount and Encashment of Earned Leave and other benefits passed in pursuance of proceedings in Lr.No.AG(A and E)/P19/II/D-100/SP731/2025-08/3407 dated 23.10.2025 of the Principal Accountant General (ABBE), Hyderabad viz., an amount of Rs.16,00,000/- sanctioned towards retirement gratuity viz., Rs.11,40,961/- sanctioned vide Token No.2602575241 dated 01.12.2025 and Rs.4,59,039/- sanctioned vide Token No.2602575273 dated 01.12.2025 respectively, further an amount of Rs.22,96,405/- sanctioned towards Commutation Value of Pension viz., Rs.16,37,567/- sanctioned vide Token No.2602575295 dated 01.12.2025 and Rs.6,58,838/- sanctioned vide Token No.2602575310 dated 01.12.2025 respectively, Final Encashment of Leave amount of Rs.16,96,498/- sanctioned vide Token No.2602331368 dated 10.12.2025, GPF amount of Rs.10,34,864/- sanctioned vide token No.2602013297 dated 21.11.2025, GPF Part final amount of Rs.19,10,814/- sanctioned vide Token No.2524193120 dated 12.03.2025, Surrender Leave amount

of Rs.1,49,251/- sanctioned vide Token No.2522499919 dated 23.08.2024, Surrender Leave amount of Rs.8'7,267/- sanctioned vide Token No. 2601018203 dated 08.08.2025, PRO Arrears (12 Bills) amount of Rs.3,94,691/- sanctioned in different token numbers on 11.11.2025 and D.A. Arrears (6 Bills) amount of Rs.45,684/- sanctioned vide in different Token Numbers during October 2025 and December 2025 in terms of the orders passed in W.P.No.40675 of 2025 dated 05.01.2026;

JALPATH REDDY SVR Advocate for the petitioner, directed issuance of notice to the respondents, herein, to show cause as to why in the circumstances stated in the affidavit filed in support thereof, the said case should not be admitted;

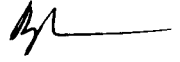
