ORDER:

Notice Before Admission.

Sri Mahesh Raje, learned Government Pleader for Home takes notice on behalf of respondent Nos.1, 3 to 6.

Sri Mahesh, learned Assistant Government Pleader for Revenue takes notice on behalf of respondent No.2.

Learned counsel appearing for the petitioners submitted that, as per the proceedings issued by respondent No.2 *vide* Letter No.E2/3397/2018, dated 29.12.2022, pattadar passbooks were duly granted to the petitioners. Based on the title conferred by the Tahsildar, the petitioners have been in lawful and peaceful possession of the subject property from the date of issuance of title till date.

Learned counsel further contended that the said proceedings have not been challenged by respondent Nos.1 and 3 to 6. However, despite the petitioners being in possession of the property, on 03.03.2026, the official respondents, allegedly misusing their authority, are attempting to interfere with the petitioners' possession without following the due process of law.

Learned Government Pleader for Home, while opposing the submissions, contended that the official respondents are in possession of the subject property. It is further asserted that, contrary to the claim of the petitioners, the petitioners are in illegal possession of the said land.

This matter requires detailed examination and the facts can be ascertained only upon filing written instructions/counter by the official respondents.
